### **Participation criteria**

The PEAK Morning Run is a non-competitive side-event which takes place within the PEAK LAKE GARDA 42 event.

Registration is valid if we have obtained all your details and you have paid the participation fee (except for special authorisation from the organiser).

To start your race, please remember to bring the registration confirmation email and an ID card with you.

The following are not allowed to participate in the race

- Non-registered persons
- Athletes with 'hand bikes', prams, pushchairs or other wheeled vehicles.

Participants who do not present themselves at the start are not entitled to a refund of the registration fee. There is no right of withdrawal.
